Why Students Fail and How to Reduce the Student Failure Rate?

The student failure rate at the AAU is fairly low but failures do occur. This is due to insufficient English, various degrees of study discipline and methods multiplied by different cultural environments, the workload of students who work; some students roll off because of a financial burden or due to their sheer neglect of duties as a student.

Many international students find it difficult to start at a university because of the cultural shock is made even more severe by their exposure to a strange cultural environment. The AAU is working with the AAU Psychological Institute (PhDr. Iva Šolcová, Ph.D.) to open a psychological consultative office where our international students can air their problems.

The AAU supports a range of measures to help students in problem situations, but in order to maintain the quality of instruction and set academic standards we do not attempt to prevent failure at all costs.

The *advising* system, together with individual interaction between study program managers and all students, helps to identify and solve many problems. In addition, students can access, in accordance with the study order, what we call our *New Start Policy*, enabling students to seek a fresh enrolment under certain conditions. Other failure prevent options include our recommendation that students register for *fewer subjects* and also register for *Intensive Academic English*.

Using the Credit System and Obtaining a Diploma Supplement Label

Study result assessment is governed by the AAU Examination Rules. The conditions a student is required to meet in the course and after study and continuous study assessment are an integral part of every study program and field.

The U.S. credit system used by the AAU has been supplemented since 2004 in all the university's official documents (transcripts, etc.) by ECTS data. Since the 2006/2007 academic year, the AAU has published a Course Catalog in accordance with the EU standards and format; its first edition was supported by funds provided by the Erasmus Introductory Grant.

Starting from the 2009 spring semester, the AAU will issue its graduates with an ECTS Diploma Supplement, in addition to their university diplomas. Please visit www.aavs.cz or www.aavs.cz or www.aavs.cz or diplomas. Please visit www.aavs.cz or <a href="www.aavs

Completion of bachelor courses requires 90 U.S. credits; master courses require 60 U.S. credits. All subjects count towards three credits each, except for the new NMgr. Arima, accredited in January 2009. One credit corresponds with one hour of instruction per week per semester, including 2-3 hours of homework. One U.S. credit counts towards two ECTS credits.

Standard duration of study is two years (bachelor degree) and two years (master degree) respectively. The study plan envisages five courses taken every semester; however, the arrangement is flexible and if a student enrolls for fewer courses his/her studies take a longer time.

To learn more about the assessment of courses, refer to the Course Catalog, available on the AAU website or in printed form. An Assessment Method is indicated for every course. So called Grading Policy is a mandatory part of the syllabus of every course and grading must be based on at least three assessment components.

AAU Interaction with Regions, Blending together Theory, Practice and Cooperation with Customers

Because of its specific character, the AAU enjoys a unique status in Prague, nationwide, and indeed also in Central Europe. We interact with state administration bodies on many agendas and seek every opportunity to provide such cooperation via government ministry grants, training programs, expertise, and the provision of opinion.

The AAU is represented in the Assembly of the Council of Higher Education Institutions of the Czech Republic, its Presidium, and its Committee for Higher Education Institutions Quality and its Assessment (Professor M. Polišenská). The AAU is a member of the Society for Research into Higher Education; the American Chamber of Commerce in the Czech Republic (AmCham); the Canadian Chamber of Commerce in the Czech Republic (A. Krautstengel, Ph.D. is member of its Administrative Board); and Cambas (Czech Association of MBA Schools). The AAU interacts with not-for-profit organizations (People in Need, Athinganoi, Civic Belarus, etc.); its teachers provide training and lectures to many private and state sector institutions, and the AAU fosters close contacts with practical professionals in the region.

Four students, graduating in 2009, had spent 1.227 and 1.997 years respectively at AAU. The shortened study period was due to transfer from other higher education institutions and recognition of their previous credits. These circumstances were explained in the text "Verification of shorter studies than standard periods shortened by one year," presented to the MŠMT on 11 January 2010. All other students graduating in 2009, i.e. a total of 60 graduates, had spent at least three years in B.A. courses, or at least two years in M.A. courses, usually one semester more, as many students do not enroll always in five courses every semester.

Buildings

AAU rents premises in the building of the Czech Grand Priory of the Sovereign Order of the Knights of Malta at Lázeňská 4 and 2, Prague 1 – Lesser Town. Due to the growing number of students and AAU's capacity requirements, new premises were leased at Letenská 1, Prague 2 – Lesser Town.

The AAU uses two wings of the palace of Grand Priory of the Sovereign Military Order of Malta, situated at (2 and 4) Lázeňská in Prague's Malá Strana (Lesser Town) quarter. The AAU registered office is at Lázeňská 4.

Courses take place in the northern wing of the building at Lázeňská 4. There are six classrooms established for this purpose from October 2008 and two seminar rooms. The classroom capacity was sufficient for 550 students. Furthermore the building houses the office rooms of the President, project managers and study program coordinators, the teachers' cabinet, and the administrative offices. Inasmuch the building is the registered address of the AAU, there is also the AAU reception desk situated there.

The first floor of the Lázeňská 2 building northern wing (with a balcony on each floor) houses a computer laboratory, equipped with 21 computers, a supervisor's cubicle, and facilities for copying and scanning texts and images and filing data, as well as printing data from files created by authorized users, equipped with microchip access cards. There is a wireless computer network in the AAU library. One seminar room was set up at this address in 2008.

The library has been recently moved to renovated historical premises at Letenská 1, located in the vicinity of AAU (within 5-7 minutes' walking distance). The Library is located on second floor of the building, handicapped access is by lift.

Its vast rooms display over 19,000 volumes, arranged according to scientific disciplines. Five of the six lounges serve as reading rooms and one lounge is equipped with computers for searching our on-line catalogue and conducting research.

The library office offers two workplaces for library management and servicing. They provide for basic library services – book check ins and check outs, consultations on the use of library funds according to various fields of study, recommendations of other library sources, and copying of documents.

Close Interaction with Other Libraries

Our contracts with the libraries of the Institute of International Relations and the Institute of Contemporary History of the Czech Academy of Sciences are a major source of information for the teachers and students of the AAU.

In September 2009 the AAU Library established cooperation with the Library of the Czech Academy of Sciences, which provides students and lecturers with access to its book fund and electronic databases (http:// http://www.lib.cas.cz/en/online-databaze). Annual student and teacher fees are paid by AAU.

Copy and Print Services

Copies are made on a Xerox multipurpose digital copier that enables printing, copying and digital scanning of loose leaves and books in a range of print qualities, formats and sizes.

Due to completion of a wireless internet project, many students stopped using the computer lab and work on their private notebooks. Therefore we closed one of two computer labs and made more space for classrooms. We are working to provide additional sites for the use of private notebooks. The computer lab now serves for classroom instruction and as a space for

students without notebooks, and those who have not brought their own gear. The rate of its utilization is around 65%.

Capacity and method of connection to internet: A high-speed direct radio router connects AAU with the MŠMT building in Karmelitská Street and provides connection with the PASNET academic network (and further with the internet); its data transmission capacity is 8Mbps.

AAU Computer Network

The AAU owns fifty-five (55) personal computers, all of which are equipped with the Windows XP Professional Operation System, or they are connected with Linux and Windows 2003/2008-based server systems.

Twenty-three (23) of the above computers are available to students (and teachers) in the AAU computer lab and reading room. These computers are equipped with Windows XP Professional. The computer laboratory features also a printing system which, together with personal identification, provision of personal print front (disabling unwanted print jobs and preventing access to another person's files), executing individual user's print tasks from the front of an authorized user logged in to any computer within the student part of the network and enabling to achieve a higher output quality, also enables scanning and copying documents (e.g. textbook duplicates) in the .pdf format. Documents can be collected also in the library .

Our computer laboratory provides students with personal accounts including profiles, personal websites, electronic mail including secure web approach on the intrnet, personal harddisk space, and printing services. The lab is open daily from 8:30 to 19:30 hrs; shortened hours are available on Weekends.

The computer laboratory has 20 SPSS statistical system licenses vis-à-vis students and teachers.

All AAU students have unlimited access to the internet; the computer lab handles many software applications including MS Office 2003, Acrobat Reader 7, etc.

Students in both buildings can also use sockets to connect their notebooks to the computer network even if do not have wireless network cards.

Five data projectors, two TV sets, two video players, one DVD player, one high-quality projection screen, five notebooks and other equipment is avaliable for instruction purposes.

A newly built multimedia classroom is equipped with a slide projector, PC notebook with internet connection, and spatial-sound DVD system. A second such classroom is under construction

The other computers are intended for teachers and administrative employees. These computers interact with one Widows 2003 server for account management and other services,

and a Windows 2008 server for an Exchange 2007 mailserver with web and direct access. Other services (including computer lab) are run through three PCs with Linux operation system and a VMware server. These machines interact as need be with mobile virtual servers built on the Linux platform. This solution extends service accessibility and significantly improves resistance against system crash situations.

The whole computer network is safeguarded by a Mikrotik firewall (which also separates student and staff parts of the network). Another Linux-equipped computer safeguards the operation of the AAU's ISIS information system.

The servers are installed in a new air-conditioned server room and the net is interconnected by means of a new one-gigabit backbone network utilizing vitual networks.

All computers feature Pentium processors or higher. All these computers are connected to the AAU local area networks and share access to the internet. Access is at present provided by an 8 Mbps radio line connecting the local area network with the academic PASNET network.

Lecturers prepare for lessons in a separate room, equipped with four computers connected to the internet and sharing a single laser printer Samsung.

The library's reading room is equipped with a Xerox laser printer, used by librarians, and a multipurpose unit combining print, copy and digital scanning functions. Admin staff and teachers use color laser printers/copiers.

The AAU encourages students to use computers in two priority fields. First, students use computers to work on instruction-related assignments, specific tasks solved with the help of the internet, and in electronic communication with teachers and peers. Second, students learn, in their data-processing courses, to explore the potential of information technologies and acquire specific computer skills.

The teaching process envisages the use of *modern communication technologies*, which would enable interactive teaching/learning over distances of thousands of kilometers. AAU plans to use e.g. the *webICQ internet program* which, in combination with two computers and web cameras, will enable effective audio and video communication in real time. These technologies, used by AAU, will enable various interactive options, including teleconferences, panels and roundtables, as well as long-distance consultations and lectures by foreign-based teachers.

3. QUALITY AND CULTURE OF ACADEMIC LIFE

Social Matters of Students and Employees

Social Matters of Employees

The AAU issues meal coupons to its administrative staff, helps foreign teachers to handle visa procedures, finds accommodation for visiting professors, and contributes towards business-related telephone bills and transportation costs of selected employees. Once every year the AAU President invites staff members for a one-day trip in the Czech Republic, with all travel costs paid, and as of 2006 the AAU has organized and paid for staff-teacher meetings. The AAU gives financial support to the scientific research activities of its academic staff.

Student Complaints and Suggestions

The AAU immediately responds to student complaints and suggestions, none of which is left unanswered. Complaints and suggestions are most often lodged by individual or collective petitions. For the further details see *Student Handbook* (www.aauni.edu)

Professional advisory services

The AAU devotes extra attention to advising its students. Specific professional advice needs to be provided to foreign students living in the Czech environment, foreign students hoping to work in their home countries, Czech students hoping to work abroad and Czech students wishing to exist in the Czech professional environment. The AAU relies on the experience of its multinational team of teachers, clerks and external employees to give the best possible support to its students. Every student goes through the advising process at least once a semester.

Other information and advisory services provided to our students

The Student Services Centre looks after nonacademic affairs. This office may be helpful in the following areas:

- Issue of certificates and declarations
- Processing residential permits
- Accommodation
- Social benefits for university students
- Scholarships
- Issue of student IDs
- Student orientation on conditions of study at AAU
- Vital requested assistance in specific situations and communication with authorities on behalf of students without permanent residence in the Czech Republic or Prague

Handicapped groups of study candidates/students in higher education institutions

AAU is located in a rented historical building, where it is not possible, for the time being, to provide access for wheelchair students; i.e. it is not possible to educate physically challenged students. In 2009 AAU hosted two exchange students diagnosed for learning disability. AAU provided them with suitable working environment and made provisions for their study.

Exceptionally Talented Students

Merit Scholarship

Merit scholarships are granted to students with excellent results.

A merit scholarship may be granted to a student that has completed at least eight courses during two semesters and achieved a GPA of at least 3.3.

Partnership and cooperation with employers in formulating and implementing study programs

Cooperation with employers proceeds at two levels:

- a. Formulating fields of study (mainly bachelor studies of Business Administration, and Journalism and Communications)
- b. Provision of internship as a compulsory part of study (see field accreditation documents)

Boarding, Lodging, and Other Services

From the Autumn Semester 2006, especially Study Abroad students have been accommodated in a family villa in Prague 8.

However, the AAU Student Services Manager makes every effort to help our students find board and lodging. This service is quite essential for students from abroad, as students from Southeastern Europe, Asia and Africa often face difficulties looking for acceptably priced rented accommodation in Prague.

Foreign exchange and internship students need to have accommodation before they arrive in the Czech Republic. However, the AAU Student Services Manager can help to find accommodation even for in-country students.

Boarding

AAU doesn't have its own dining facility. From April 2006 Student can board at the student's canteen of law faculty of Charles University under the same conditions as Charles University students. There are several restaurants near the School, which provide lunch menus for reasonable prices.

Support Scholarship

Support scholarship is granted to students whose financial situation precludes them from paying the full amount of fees as required by the AAU. In accordance with the mandatory procedure set by an internal regulation, a limited number of students, who have proved their situation, and based on the recommendation of the AAU Scholarship Committee, may pay only a part of the required tuition fees.

A support scholarship may be granted to a student that has completed at least one semester of study and whose overall average proficiency rate according to Grade Point Average (GPA) assessment in accordance with Article 8 of the AAU Study and Examination Rules amounts to at least 2.5.

The maximum amount of cash granted to a student reduces his/her total tuition fee by 25 per cent. Inasmuch the objective of this scholarship is to help as many students as possible; the actual reduction in individual cases may be less than 25 per cent.

Social Scholarship

In 2009, no regular AAU student claimed a social scholarship in accordance with Section 91 Para 3 of (Higher Education) Act 111/1998 Coll. (amended and considered).

Special Scholarships

One of the missions of the AAU is to help the formation of an open civic society.

Therefore the AAU offers special scholarships to students of Roma origin and refugees who have been either granted asylum on the territory of the Czech Republic or applied for such with the recommendation of applicable authorities.

The AAU makes every effort to help integrate citizens of Roma origin and refugees in the academic, political and business spheres as well as to increase the number of ethnic minority students in higher education and assist minority integration in a majority society.

Every year, the AAU grants two scholarships to Roma students, and one refugee scholarship. Students on such selective scholarships will not pay tuition fees during their studies at the

AAU provided they observe the AAU rules and their overall average proficiency rate according to Grade Point Average (GPA) assessment in accordance with Article 8 of the AAU Study and Examination Rules amounts to at least 2.5. The AAU did not grant such scholarships to any new student.

In 2006 the AUU decided to grant, as from 2007, annual scholarships covering any and all study costs of one handicapped student. Such student will have scored GPA 2.5 or more. In 2007, a *Handicapped Student Scholarship* was introduced; no new AAU student applied for such scholarship in 2009.

37 merit-based scholarships, 14 social scholarships, 4 special scholarships (2 Roma, 2 refugee) were used by the AAU students in 2009

4. Internationalization

Strategy of private higher education institution in the field of international cooperation; priority spheres

Internationalization is one of the core characteristics of AAU and an important component of its long-term strategy. In 2009 internationalization was substantially intensified and deepened. One of the indicators of this development is the fact that at present, AAU reports 1/3 of Czech and 2/3 of foreign students, in contrast with the previous years, when the ratio was 50:50.

AAU's internationalization approach in 2009 mainly consisted in (1) effective implementation of the Erasmus Program on the basis of agreements signed; (2) further development of cooperation with Chapman University, CA, USA* and within the framework of the Arima field of study; (3) negotiations on establishing Erasmus-based cooperation with University of Malta's Mediterranean Academy of Diplomatic Studies; (4) active penetration into the international university environment; (5) bilateral negotiations with a number of European and non-European universities on mutual cooperation and student exchange programs (Malta, Cyprus, Florida and Puerto Rico; (6) participation in education trade-fairs and in the distribution of all available information about other European programs – AAU officials attended seminars and other informative events organized by the Ministry of Education; and (4) promoting the trend of semestral and year-long presence of study abroad students especially from the USA. In the process of instruction AAU increased its use of guest teachers from the Prague Diplomatic Corps and the Czech Ministry of Foreign Affairs and organized other Ambassadorial Series events (see the list of academic activities).

*In addition to ongoing cooperation with the Argyros School of Business and Economics, AAU established academic contacts with the Chapman University School of Law (California) and Arizona State University's Sandra O'Connor College of Law and started negotiations on the development of joint master programs to be taught at AAU.

Participation of private higher-education institution in international education programs and research and development programs

a) Erasmus: agreements in progress

In 2007 AAU received an Extended Erasmus University Charter for 2007-2013.

The main partner and project organizer is Fachhochschule des bfi Wien, GmbH, Vienna, Austria, represented by Professor Helmut Holzinger and Professor Rudolf Stickler, who has been a member of the AAU Scientific Council since 2009. Other partner organizations are Yedepe University, Istanbul, Turkey and Karol Adamiecki University of Economics, Katowice, Poland.

5. Quality assurance of activities carried out in higher education institutions

Education quality assurance system of private higher-education institution – internal and external evaluation

In 2009 AAU was evaluated by the accreditation commission. In the course of preparations for the evaluation, AAU utilized findings from seminars on the standards of Quality Assurance in European Higher Education Area and its experience from the Commission on Quality of Higher Education and its evaluation by the Council of Higher Education Institutions. AAU adopted a series of internal measures: existing internal assessment was complemented by a second level of internal evaluation and AAU released a Self-Evaluation Report as a background for assessment by the Accreditation Commission.

For more detailed information on the strenuous process of internal and external evaluation see the Self-Assessment Report and a report on the evaluation process, available on the website of the Accreditation Commission, cited below:

Report of Accreditation Commission on Evaluation of Anglo-American University, o.p.s.

June 2009 Introduction

The Accreditation Commission (hereinafter AC) ruled at its session, held on 20-21 November 2007 in Brandýs nad Labem that in accordance with Article 84, Paragraph 1, Letter a) of Law No. 111/1998 Coll. concerning higher education institutions and a modification and amendment of other laws (the Higher Education Act), an evaluation of the Anglo-American University, o.p.s. (hereinafter AAU) shall be carried out. For this purpose the AC appointed a task working group, consisting of: Vladimíra Dvořáková – Chair, Svatava Raková, Milan Sojka, Blanka Říchová, Petr Vymětal and two representatives of the Students' Chamber of the Council if Schools of Higher Learning - Radovan Igliar and Jiří Mašín.

The task working group had the following background materials for the evaluation process:

Evaluation report produced by AAU, whose structure meets task working group requirements,

Specific background materials requested by the task working group and concerning mainly defended qualification papers and their documentation,

Findings obtained during a visit to AAU on 30 April 2009,

Public information and/or information accessed by the task working group at AAU website.

The task working group's visitation to AAU took place on 30 April 2009 and the visitors were: Vladimíra Dvořáková, Svatava Raková, Blanka Říchová, Petr Vymětal, Jiří Mašín and Radovan Igliar. The visitors held discussions with the AAU's management, academic staff and students and inspected the AAU premises, including the library. The AAU management provided them with information on the access to electronically published final papers and their assessment, the quality of which the group judged after the visitation at AAU. Upon the visitation, AAU provided certain other inputs concerning the pipeline institutional accreditation by a corresponding U.S. accreditation commission (Western Association of Schools and Colleges – this accreditation had

been offered on the face of evaluation of the AAU MBA programme and is considered prestigious within the American environment), as well as the AAU scholarship program. The task working group examined only the programs and fields of study accredited in accordance with applicable Czech legislation (the Higher Education Act), i.e. leading to the acquisition of Czech higher education; the task working group did not examine the quality of foreign programs mediated through AAU.

The AC hereby observes that AAU created very good working conditions for the task working group, enabling its members to meet the management, teachers, students and administrative staff and enter the premises in which instruction takes place.

1) Capacity for critical reflection of development of the institution and the ability to adopt adequate measures

The AAU management presented a very thorough report, openly analyzing fundamental development trends, the strong and weak points of the institution, and in case of stated weak points also presenting basic ideas about correcting them, including deadlines (more or less specified; in some cases we were frankly told that the problem had yet to be thoroughly addressed and appropriate measures taken in due course).

The AC's evaluation of the report is positive as it demonstrates the organization's capacity for self-reflection and ability to react to problems. The AC nevertheless believes that two problems have not been completely reflected (although they have been specified), or rather the reflection does not go deep enough and the depth of the strategy to address them is not completely adequate, either. They are two fundamental problems that naturally arise not only in private higher education institutions, namely a) personnel provisions to ensure accredited programs of study and b) creative and scientific activities of the academic staff of the institution.

2) Accredited fields of study and instruction

The AAU was accredited three BA programs of study (with four fields of study) and five ensuing MA study programs (with five fields). The structure of programs and fields of study is basically adequate, although in some cases, due mainly to lower student interest, some BA courses may become reduced in scope and size. In this context the AC recommends an analysis of the relatively low interest in the ensuing Public Policy MA program. It is safe to say that AAU tries to keep a certain logical profile and not to venture into the expansion of "new" programs, for which there would not exist a sufficient background.

The AAU system of management and evaluation of teaching programs is based on the US tradition, as is the credit system, albeit translated into ECTS. A certain reform of the credit system, which would diversify students' work load, is expected to be carried out by 2010. The AAU's internal organization is based on an internal system of grants responsible for the given field of study. AAU applies an internal evaluation system, periodically updated according to date provided to us. However, internal evaluation outcomes are not published (much less made available to students, who would appreciate a certain form of feedback). However, study options at AAU are sometimes complicated by problems related to procuring visas for foreign candidates. In the implementation of accredited programs and fields of study, no major changes have occurred, which would have impact on the graduate's profile. As a rule, accrediting and reaccrediting programmes of study often fail to sufficiently reflect the region, in which the subjects are taught (lack of specialized English-language output of Central European authors, especially in the study of cultures, transformation processes etc.).

Fairly positive evaluation should go to the AAU program of assistance to less successful students through special courses etc. without reducing requirement for quality – "start again" program and scholarships.

The AC has checked the quality of several final theses, available on the internet. For the time being, only papers from the most recent period are available on the net (Academic Years 2007/2008 and 2008/2009); more outputs are being added. AAU does not publish papers involving sensitive corporate data and some files are difficult to access due to technicalities. Papers are published together with assessments by thesis managers and opponents. Their quality basically meets requirements: papers specify their objectives and methodological approach, stating scientific apparatus used; papers of poorer quality are displayed with critical remarks by the project opponent and/or project manager.

Hovever, certain objections and requirements for improvement need to be highlighted. First, not all papers, published on the web, meet formal requirements, such as the absence of a statement about independent treatment, the abstract of the paper, the title page is often missing and it is not quite possible to establish whether this due to the electronic filing system and how far the electronic version of a thesis corresponds with its actual paper form. Second, thesis topics are sometimes quite remote from the student's actual field of study. Reviews are usually well detailed but the recommended overall rating is not always stated. Reference sources (literature etc.) and formal layout also deserve greater attention.

3) Human resources

AAU doubtless does not underrate the sphere of human resources, to which constant attention is being paid. However, the situation is far from ideal. On the positive side, there are no "flying professors" to be found. Many of AAU teachers have experience in teaching at foreign institutions and thus also certain higher standards of approach to students, thereby strengthening the international and multicultural character of instruction. Teachers tend to make a stable presence, many of them have been there since the AAU's foundation, i.e. they do not come and go, semester-wise, except for some "visiting professors". Nevertheless, the existing core cannot be deemed completely satisfactory – in every field of study there are several qualified full-time teachers, however, they simultaneously appear in other AAU programs/fields of study (i.e. they do not change workplace). AAU feels this issue is important, especially as far as ensuing master studies are concerned, inasmuch it is necessary to strengthen the core teaching staff, who will be "drivers" of the field.

4) Creative, scientific and research activities

AAU pursues creative, scientific and research activities. AAU is a researcher or co-researcher of scientific grants (including Czech Science Foundation - (GAČR) grants), regularly looks to find other grant options, and presents the publications of its own (including external) researchers, originating in association with its mission. As evinced by the AAU self-evaluation report, AAU does appreciate the need to involve students in creative and scientific activities, as wells the publishing activities of its staff. The report also acknowledges an often lower level of liasison between foreign employees and the Czech scientific community. It seems, however, that the proposed solutions are not always ideal, nor do they pave the way to finding relevant solutions to other problems. First of all, greater involvement in creative and scientific activities is ideal through the themes, outlined by BA and MA theses, invited by the researches of specific research objectives. The foreign staff's engagement in Czech scientific activities must be informed namely by publishing in scientific periodicals, participation in various conferences, and inviting a wider circle of researchers in original projects. The AC does not consider the creation of indigenous working papers quite suitable, as this form is relevant only for major research projects, whereas in normal circumstances this will rather lower the competitiveness of outputs and is generally not properly evaluated. The relatively high number of foreign teachers should be rather used in expanding scientific cooperation with foreign countries. Also quite problematic is the fact that research projects or publishing activities are not always remarkably associated with the education

work (through accredited programs and fields of study, or rather the subjects taught by the higher education institution).

5) Library and general situation

The library and computer rooms are situated in another building. The library is rather well equipped with a quality book fund, comprising a wealth of scientific publications and partly also fiction books and periodicals printed on-line. The nearby library of the Institute for International Relations is used especially by teachers of specific subjects. Students evaluate their access to literature as satisfactory.

AAU enjoys the privilege of good address; the ambient environment is pleasant but the future calls for more provision for space (in regard of sheer capacity) – something the AAU management recognises as a problem.

AAU has a dedicated information system that needs to be completed. It is safe to highlight certain problems with publishing and organising papers and enhancing their usefulness.

6) Students and conditions of study

It follows from interviews with students that the AAU management, teachers and administrative staff have a sound idea about students' requirements. Their attitudes are forthcoming in respect of students' affairs, as well as their needs indirectly associated with study (e.g. leisure activities). They do appreciate the student's status as a partner, rather than a recipient of a service. The interviewed students rarely expressed reservations about some teachers. Access to information, consultation hours, library and study rooms is above average. Students can avail themselves of career advice. AAU supports extracurricular activities, organized by the Students' Council (students praised issues including the sorting out and recycling of refuse and the AAU's pleasant environment).

Positive ratings went to the system of scholarships (for Roma students, refugees, victims of natural disasters, partial stipends for students in dire life situations).

AAU engages students in work for the benefit of their institution. In this way, students can earn incomes to pay some o their tuition fees and become more involved in a union with their alma mater. In addition, this involvement gives them a better insight on each party's optics of insider issues and gives AAU better possibilities to develop and improve the course of education. Particular reservations revealed the need of greater student mobility – e.g. through involvement in the wi-fi eurodam connection (with 300 hot-spots across the Czech Republic, available to students all over Europe) and better access to foreign exchange schemes. Also worth noting is the possibility of creating a storage space for subject-related study documents to be used by teachers, who currently publish such documents on their personal websites. On the whole, it is adviced that better approach to e-learning documents would not be out of place; students sometimes objected a fuzzy approach to writing study schedules.

The general atmosphere at AAU gives a very positive impression and it is obvious that various events are organized in the realm of both creative and scientific action and student-organized events.

Conclusions

AAU implements BA and MA study programs in accordance with the conditions declared in applications for the accreditation of programs and fields of study and there are no major departures from the student's profile. There have been no graduates so far of some fields of study. Instruction is well organized, students are in contact with their teachers and enjoy appropriate conditions of study and assistance. Although the human resources situation is improving and prominent foreign employees have been recruited, the emphasis will have to continue to be on qualification growth and personnel stabilization. AAU pursues creative activities and scientific grants are being solved; however, research has to become more intertwined with educational

activities. The AC would deem it suitable for the foreign teachers to become more integrated in the Czech scientific community.

The general atmosphere at AAU should safely be described as positive; students' communication with teachers and management workers is of high quality. The shortcomings, detected by the AC, relate to certain formal requirements for qualification papers and their electronic reviews. The themes of individual papers need to be more thoroughly premeditated.

The AC agrees to extend the accreditation of all programs of study until 31 July 2015 (unification of accreditation terms of all programs of study with the term of accreditation of ensuing MA study program, International Relations and Diplomacy).

Recommendations

- 1) Improve formal aspects of BA and MA theses and ensure their remote accessibility.
- 2) Check suggested themes and their implications against the graduate's profile, evaluate the outcomes of first MA program graduates in new fields of study.
- 3) Improve teacher's contacts with the Czech scientific community, strengthen the projection of a region into the instruction process (reference literature) and deepen international cooperation in research and education
- 4) Gear scientific, research and creative activities towards programs of study under way.
- 5) Improve the human resources policy. Strengthen the core of full-time teachers at AAU without any firmer ties to another workplaces
- Focus particularly on young perspective workers, who have already finished a doctoral study or who are in the final phase of a doctoral study and they publish a lot.
- 6) Encourage publishing activities of teachers in the Czech academic environment. Make use of the relatively high number of foreign contributors to extend scientific cooperation with foreign countries.

The AC wants to be presented with an auditor's report on meeting these recommendations in June 2011 and demands acess to defended BA theses.

Students' participation in the internal evaluation system

The fundamental characteristic of students' participation in the AAU internal evaluation system remains unchanged, therefore please refer to Annual Report 2008, which provides an in-depth treatment of the topic.

A new quality-enhancing aspect takes the form of cooperation with the CEA (Cultural Education Exchanges) agency, providing for study-abroad students from the United States. Since the Autumn Semester of 2009 we have worked with the CEA to develop evaluation forms, which would include more evaluation criteria and provide better feedback.

6. DEVELOPMENT OF A HIGHER EDUCATION ESTABLISHMENT

The AAU prioritizes its national and international development. Established in 2008, the University Advancement Department is an organic and functional umbrella for marketing and PR, student recruitment and admission, establishing relationships with national and international education establishments, fundraising and general development, and promoting the institution's good name and visibility on the Czech and international education markets. We opened our Alumni Office to look looks after AAU graduate affairs and in order to establish an AAU Career Center to provide internship schemes, future professional opportunities for graduates, their further education and preparedness for success over and above the limits of our study programs, as well as student mentoring and shadowing programs.

The AAU University Advancement Department consists of: Marketing and Admissions Office, International Programs Office, Alumni Office a University Advancement Office.

Emphasis on proactive approach to self-presentation, intensive communication with would-be students and vigorous expansion on the international education market, coupled on care for alumni and students as clients – all this is in line with the Anglo-Saxon education tradition and the active approach policy displayed by U.S. universities.

The AAU is a member of the global organization associating educational institutions and ICEF and ICEF Online recruitment agencies and it has presented itself in strategically selected regions (U.S. workshops for the Americas, Dubai for the Middle and Near East and Asia, and Moscow for the countries of the former Soviet Union). The AAU attends European education fairs (Serbia: EDU Fair and MBA Fair, March 2008) as well as national education fairs (Gaudeamus, Brno and Prague).

The AAU actively contributes to specialized HR and management periodicals and presents its programs to companies (over 20 firms approached and shown personal presentations), schools (secondary schools throughout the Czech Republic and Slovakia), as well as various professional forums (Canadian Chamber of Commerce, Young Professionals Forum, Global Youth Leadership Program, etc.).

AAU Participation in Programs Financed by the EU

The AAU participates in the ARIMA International Joint Study Program supported by an European Union grant; however, this project is not financed by the EU Structural Funds but is granted by the Education, Audiovisual and Culture Executive Agency, Erasmus – Jean Monnet Centres).

Concluding remarks by the AAU President

Anglo-American University in Prague is the oldest private institution of higher learning in the Czech Republic and since its foundation in 1990 it has provided quality BA and MA education to students from dozens of countries around the world.

In 2009 our enrolment continued to grow, for the first time exceeding five hundred students and reaching 562 in the autumn. We are pleased to note that this trend is not to the detriment of high enrolment standards; rather the opposite is true. On average, AAU accepts four candidates in ten – a proportion that, we believe, can be reported by few Czech private institutions of higher education. The ratio of Czech students at AAU has been declining over a long time (although it remains virtually constant in absolute figures) and amounted to about 20% in 2009. This proves that AAU is a school for the world, since rapid enrolment growth is recorded among foreign students, and not Czechs. However, this is not to say that we do not welcome Czech students of quality.

In addition to the nationality breakdown of students, the international character of this higher-education institution is reflected also by the system of instruction, the composition of teachers (we employ exclusively specialists with international academic and practical experience, including alumni of Harvard, Yale or Stanford), as well as by AAU's organizational structure and campus facilities.

It goes without saying that academic growth is AAU's top priority. As well as acquiring new accreditations and constantly upgrading the teaching staff, AAU has entered into the preparatory stage of filing an application for an institutional accreditation by WASC (Western Association of Schools and Colleges), a top-class world institutions that grants accreditations to the likes of Berkeley, Stanford and CalTech, and into the preparatory phase of application for a US Federal Loan Eligibility status, which would open AAU to hundreds, maybe thousands of US high school graduates, paying for their education through US government loans. In the field of science and research we take pride in the activities of our employees as well as organizing a number of seminars and conferences. Hand in hand with academic growth goes the development of our campus. We have rented a third Lesser Town palace, moved our library to more representative premises, opened a Gift Shop & Information Center, established state-of-the-art teacher premises. upgraded and refurbished all our premises from classrooms to the students' center to the reception desk and common spaces, and taken preparatory steps to open a dedicated cafeteria and start developing our own dormitories. In the field of marketing and public relations, we have scored important successes at home and worldwide, and close interaction with our alumni has proven beneficial.

Global economic downturn has had no adverse impacts on our higher-education institution; in fact, enrolment is vigorously growing. All this goes to show that we offer top-notch university instruction in English in a beautiful environment and for a very acceptable price. We look into the future with great optimism and bold plans.
