1. Introduction

Anglo-American University is the oldest private higher education institution in the Czech Republic. Founded in 1990, it provides high-quality education on the level of bachelor's and master's degrees to students from all over the world.

One of our main strategic aims is to raise awareness of AAU both in the Czech Republic and abroad, in Central Europe as well as throughout the world. We strive to present the University as the interesting and attractive institution it is, offering prestige and interesting future prospects to the growing number of talented home students. Over two thirds of AAU students are enrolled in full-length programs, with only the remaining one third (mostly students from the USA) attending the University for only one or two semesters; however, every year some of these end up changing their plans and complete their studies at AAU. In the spring semester of 2014, a total of 852 students were enrolled at the University.

The international character of AAU can be seen not only in the students' international backgrounds, but also in the educational system, the backgrounds and professional experience of lecturers, the University's organizational structure and campus facilities.

AAU's primary aim has always been (and always be will be) academic development. The University has intensified the process of increasing teaching quality through selecting qualified lecturers to work at AAU, and by providing leadership to academic staff (i.e. lecturer training or the implementation of a teaching evaluation system – teaching peer reviews, syllabus evaluation by heads of department, student assessment evaluation, etc.). In 2014, one of AAU's main aims was also to continue the process required to receive the institutional accreditation awarded by WASC (Western Association of Schools and Colleges); in September 2014, a WASC team of experts evaluated the University on-site as a part of an Educational Effectiveness Review Site Visit. AAU's WASC Steering Committee continued its work in 2014, as did several other affiliated committees (e.g. the Learning Outcomes and Committee. the Curriculum Committee, Library Assessment the Committee and the Academic Writing & Information Literacy Committee).

The results of the committees' work were used as a basis for a re-accreditation application presented by AAU to the Accreditation Commission of the Czech Republic. The main emphasis was placed on the Academic Program Review, which had been carried out for every study program taught at AAU.

In the field of research and scientific development, AAU can pride itself not only on the activities of its lecturers, but also on organizing several seminars and conferences, and on an active cooperation with a number of businesses and institutions in the Czech Republic.

At the end of 2014, the University moved to new premises – into the reconstructed Thurn-Taxis palace. For this reason AAU did not invest significantly into on-site facilities at the old premises prior to the move.

In 2014, the University also successfully finalized the process of updating ongoing contracts that have been entered into under the Erasmus LLP program. All of these contracts now fulfil the requirements and criteria of the program's successor – Erasmus+.

The interest that the media and the general public have shown in AAU, together with the fact that our alumni can be found in leading positions throughout the world, confirm that Anglo-American University is continuously consolidating its position as a leader in English-language higher education in non-English-speaking countries.

AAU's Mission, Vision and Strategic Aims

Anglo-American University is registered as a public service company ("obecně prospěšná společnost") under Czech law. Its educational methodology is based on British and American educational principles and on proven traditions of the Central-European educational system, and its mission is to provide its students with the skills necessary for using their education to achieve positive changes in a local, national and global environment:

"Graduates of the Anglo-American University are prepared to make a positive difference addressing local, national and international challenges through the analysis and application of current and developing knowledge in the context of a globalized world."

The educational philosophy of AAU remains unchanged, emphasizing learning in English, studying in small, interactive groups, and focusing on critical, creative and independent thinking. The academic community at AAU has a distinctively international character – over two-thirds of the students are international, and the academic staff includes specialists from several countries – from the USA and the Czech Republic to Western Europe, Scandinavia,

and Asia. AAU's strategic plan is to continue expanding and intensifying the University's international character.

AAU's main aim is (and always will be) a continuous amelioration of the quality of teaching, research activity development and academic development in general. The lecturers' primary aim is to provide students with an excellent understanding of the studied disciplines and with the interdisciplinary knowledge related to these fields. Students leave AAU equipped with sound theoretical and methodological knowledge as well as the ability to identify, analyze and use various resources and sources of information, allowing them to apply these skills in real-life work situations. Their performance should also meet the highest criteria on the international level, as they will be able to independently identify and solve problems using innovate methods. AAU graduates will be able communicate in English both orally and in writing, and will be able to further their own vocational and professional development, as well as the development of other individuals and groups. Last but not least, AAU's mission also covers the development of civil responsibility and ethical values.

In pursuing these objectives, AAU's guiding principle is the three-tiered system of learning outcomes: the level of the institution, the level of the study field and the level of the course.

In 2013, accreditation was extended for the following study fields: *Business Administration; Humanities, Society and Culture; International Relations; International Relations and Diplomacy.*

In 2014, one new study field was accredited: Visual Arts Studies.

Accredited AAU study programs described by the method of Learning Outcomes in accordance with the National Framework for Higher Education Qualifications

In 2014, AAU described 13 study programs accredited by the Ministry of Education, Youth and Sports of the Czech Republic (15 degree courses in total) by the Learning Outcomes method. As a result, 100 percent of AAU's study programs and study fields are now described as required by the Learning Outcomes method.

The Credit System and the Diploma Supplement Label

Study assessment follows AAU Examination Rules. The conditions each student must meet over the duration of the course and at its conclusion form an integral part of every study program and field, together with the continuous evaluation that takes place throughout their studies.

AAU uses the US credit system. From 2004, the US credit data have been supplemented by ECTS data on official documentation (e.g. on transcripts). Starting in the spring semester of 2009, AAU has also been issuing an ECTS Diploma Supplement with each AAU diploma. In 2011, the University was awarded the Diploma Supplement Label for 2011–2014 by the European Commission.

A bachelor's degree is equivalent to 90 US (180 ECTS) credits, a master's degree to 60 US (120 ECTS) credits. All subjects taught at AAU correspond to 3 US credits, with 1 US credit being the equivalent of 2 ECTS credits.

The standard length of studies required for a bachelor's degree is three years, with two years being the standard length for a master's degree. Although the study plan requires the students to register five subjects per semester, it is flexible and if someone registers less than five subjects, they can prolong their studies.

To learn more about individual course assessment, please refer to the Course Catalogue available on the AAU website or in printed form. In the Course Catalogue, an Assessment Method is provided for every course, with the Grading Policy (assessment specification) being a mandatory part of every syllabus. Grading must be based on at least three assessment components.

Admission

<u>Undergraduate</u> (Bachelor's) Study Programs Admission Requirements

Applying for entry is subject to the Study Code of Anglo-American University, available on the University's website.

In order for the prospective student's application to be considered, the following documents have to be provided:

- a) Proof of having completed secondary education (a notarized copy of a high school diploma);
- b) The AAU Application Form;
- c) Two letters of recommendation;
- d) A cover letter in the form of an essay on the topic of "Why I Am Applying to Study in this Field" (part of the Application Form) and an interview on the same topic held in English;
- e) A résumé, a copy of your passport, a photograph and the application fee.

For applicants whose first language is other than English, the University sets a minimum English language proficiency level for study purposes:

- TOEFL (Test of English as a Foreign Language): 525 points in the standard version,
 197 points in the computer version or 71 points in the online version. AAU organizes
 TOEFL tests on a monthly basis.
- IELTS (International English Language Testing System): overall score 6.0
- CAE
- The General State Examination
- FCE (A or B)
- City and Guilds IESOL (B2)

Applicants who hold the International Baccalaureate (IB) do not have to sit an English language exam. AAU accepts students regardless of religion, age or social or ethnic backgrounds.

Graduate (Master's) Study Programs Admission Requirements

In order for the prospective student's application to be considered, the following documents have to be provided:

- a) Proof of having graduated from an accredited undergraduate (bachelor's) study program;
- b) Two letters of recommendation from lecturers in the student's undergraduate study program;
- c) A cover letter in the form of an essay on the topic of "Why I Am Applying to Study in this Field" (part of the Application Form) and an interview on the same topic held in English;
- d) A résumé, a copy of your passport, a photograph and the application fee.

For applicants whose first language is other than English, the University sets a minimum English language proficiency level for study purposes:

- a) TOEFL (Test of English as a Foreign Language): 550 points
- b) IELTS: 7 points
- c) CPE (Certificate of Proficiency in English)
- d) CAE (Certificate in Advanced English): A, B or C
- e) City and Guilds (IESOL): C1
- f) The General State Examination

As many of AAU's lecturers obtained their education abroad, the University's internal requirements do not use the university lecturer classification that is compulsory for state-run universities in the Czech Republic.

In order to provide the data the Ministry of Education, Youth and Sports of the Czech Republic requires for comparative purposes, we have grouped AAU lecturers into the following categories:

- **Instructors** hold a bachelor's degree (including any foreign equivalent requiring 3 or 4 years of tertiary education);

- Lecturers hold a master's degree (including any foreign equivalent requiring at least 4 years of tertiary education);
- Assistant Professors hold a post-graduate degree (Ph.D., CSc.) or are AAU lecturers with the status of "Senior Lecturer" or "Long-term Lecturer" who cannot be placed in a higher-qualification category on the basis of habilitation (Docents, referred to as Associate Professors) or an appointment as a university professor in the Czech Republic or abroad (Professors).

To arrive at the adjustment, the agreed commitment stated in the work contract was used; in other cases a proportionate adjustment was used according to the following percentage of commitment to number of lectures for the whole of 2014:

Of the 149 academic staff members teaching at AAU in 2014, 96 had a foreign citizenship.

The AAU Career Code and Employee Motivation

In 2014, AAU followed the Career Code, which falls under the Academic Code of AAU and has also been published in the Lecturer's Handbook. The code describes salary levels and academic staff promotion (Lecturer, Senior Lecturer, and Long-term Lecturer).

In the case of academic staff, the main motivation is **rewarding publishing activity**, further specified according to the type of academic work published (monographs, articles in journals with a high impact factor, articles in peer-reviewed journals, articles in collections, etc.). The reward does not extend to work published under the name of a different university. In addition to these publishing rewards, each AAU school is allocated a conference fund, which is used to partly fund conference participation, and a budget for rewarding **outstanding results**. Outstanding results by non-academic staff are rewarded by a **bonus** at the suggestion of the Head of Department, approved by the President of AAU.

8. Student and Employee Welfare

Scholarships

Merit-based Scholarships

In 2011, AAU's scholarship fund was significantly re-structured, allocating a larger budget to merit-based scholarships. Considering the considerable increase in study fees, which took place at the same time, the ability to grant more merit-based scholarships became an important way to decrease the study fees of talented and hard-working students.

These scholarships are automatically granted to any student meeting the requirements listed on the University's website (http://www.aauni.edu) – it is not necessary to apply.

In 2014, AAU granted a merit-based scholarship to 100 students.

Need-based Scholarships

Need-based scholarships are granted to students who are unable to afford full AAU study fees. The conditions for being granted a need-based scholarship can be found on the University's website.

Special Scholarships

One of the topics covered by the University's mission statement is supporting an open civil society and in accordance with this aim, AAU offers special scholarships for students of Roma ethnicity and for refugees who have been granted asylum status in the Czech Republic and have been recommended by appropriate authorities.

Through these scholarships, AAU aims to support the inclusion of citizens of Roma ethnicity and refugees in an academic, political and business environment, to increase the number of students from cultural minorities in the tertiary-education system, and to facilitate the integration of minorities into the majority society.

In 2014, AAU granted 7 scholarships to students of Roma ethnicity and 6 scholarships to refugees.

Handicapped Student Scholarship

Starting in 2007, a Handicapped Student Scholarship is available for one handicapped student, covering the full costs of study.

Several scholarships are also available to students studying in the undergraduate Journalism and Communications program.

In 2014, AAU granted scholarships to 143 students.

Counseling and Consultation Services

AAU understands the importance of student counseling and consultation services (Advising). Due to the University's international character, the counseling center covers various topics – counseling foreign students in the Czech Republic, assisting foreign students in finding employment in their home countries, helping Czech students make a transfer abroad and providing advice to Czech students looking to find employment in the Czech Republic. AAU benefits from the experience of its international team of academic, non-academic and external staff and aims to provide their students with the best possible support. Each student goes through the Advising process at least once per semester.

At the end of 2012, AAU established a psychological and personal counselling center, available to students once per week. In 2014, the counselling center was fully available to all AAU students.

Other Student Information and Consulting Services

The Student Services Center focuses on non-academic affairs and can help students in the following areas:

- The issuing of various certificates;
- Residential permits;
- Accommodation;
- Welfare benefits available to university students;
- Scholarships;
- Student ID cards:
- An orientation program that introduces students to studying at AAU;
- Assistance requests for communicating with authorities and in other specific cases, available to students whose permanent residence is not in the Czech Republic.

Students with Special Needs

The premises of the University consist of historical buildings, making it impossible to provide easy access to all its lecture rooms. It is therefore regretfully unable to accept physically handicapped students. AAU does, however, do its best to assist other handicapped students by offering individual study plans.

Accommodation

The AAU Student Services Office provides assistance (by means of specialized partner agencies) to students looking for accommodation. This service is particularly important for international students, as these often face difficulties trying to find acceptably-priced accommodation in Prague, but is also available for home students.

Employee Welfare

AAU provides lunch vouchers for administrative staff, assists lecturers from abroad in obtaining visas, finds accommodation for visiting professors and provides cell phones for key staff members. Once per year, the University holds a President's Day, on which organizes a field trip in the Czech Republic. AAU also organizes and co-funds staff and lecturer meetups and supports (co-funds) the research activity of its academic staff. To the great benefit of both the students and the lecturers at AAU, the AAU Library has a cooperation agreement with the library of the Institute of International Relations and the Institute for Contemporary History of the Academy of Sciences of the Czech Republic.

The Academy of Sciences grants AAU students and lecturers access to its stacks and electronic databases (http://www.lib.cas.cz/en/online-databaze) on the basis of individual reader identity cards.

Copy and Print Services

Several Xerox and Minolta multipurpose digital printers are available in the AAU Library, offering printing, copying and scanning services in a range of print qualities, formats and sizes.

Today, most students work on their own laptops and AAU accommodates this growing trend by providing WiFi throughout the university campus. The computer lab is used as a lecture hall, but remains open for students who do not own a laptop, or do not have it with them at the moment.

The WiFi is available only after logging in – user logins, which identify logged-on users, are available only for students enrolled in that particular semester. The WiFi cannot be accessed without valid login information.

The WiFi system is based on dual Hewlett-Packard access points with a centralized WiFi controller. This solution points out places with worse coverage, distributes load evenly, allows moving from one connection point to another without losing connectivity and other similar advanced functions.

Internet connection and capacity: An optical fiber cable connects the University's main building on Letenská 5 to the PASNET academic network and, through PASNET, to the Internet (100 Mbps bandwidth). The lecture halls at Letenská 1 are connected to the main building by a private, directional WiFi connection with a capacity of 250 Mbps.

The AAU Computer Network

In 2014, Windows 7 was installed on 94 of AAU's PCs. ICT services are provided by seven virtualizing and data servers running Nas4Free and Proxmox, and all services are virtualized. The servers are stored in a new air-conditioned server room and all key infrastructures are backed on intelligent UPS units.

25 of these computers are available to both students and lecturers in the computer lab and the library reading room. The PCs run Windows 7 and are periodically updated. At the end of 2014, all PCs in lecture halls and in the computer lab were completely replaced by faster computers with SSD drives.

In places accessible to the public, AAU uses the SafeQ centralized printing job management system. This system identifies individual users through RF ISIC/ITIC cards, allows for the setting of print quotas and grants them access to selected multifunctional printers. The management system also controls personal printing queues. Multifunctional printers offer double-sided printing as well as scanning into PDFs and copying services.

All AAU students and teachers use the ISIS information system. Individual courses are supported by Google Apps.

The AAU computer lab allows students to set up personal accounts that include custom profiles, personal disk space and printing services. Several other services are offered through Google Apps (e.g. Google Drive, personal webpages, Hangouts, YouTube etc.). The computer lab is open daily from 8:30 to 19:30, though the opening hours are shorter during the weekend.

Every lecture room is equipped with a PC, a data projector and a sound system for teaching purposes. The University also provides access to two TV sets, two video players, one portable DVD player, high-quality projection screens, laptops and other equipment.

The other computers are intended to be used by lecturers and administrative staff. These computers run on two separate Windows servers, which manage accounts and provide several other services. A Unix Zimbra Collaboration Server is used for collaboration and mail services; it is a locally run cloud solution with a web interface.

Two separate rooms containing ten PCs with an Internet connection and laser printers are available to lecturers.

The computer network is secured by a Mikrotik firewall, which also separates the network and the WiFi system into a student section and an employee section. The network is based on advanced HP switches linked by a redundant optical cable (20 Gbps).

A multifunction laser Xerox printer has been made available to the librarians in the library reading room, as well as two multifunction Minolta printers, which can print, copy and scan. Black and white and color printers are available to both lecturers and administrative staff.

AAU encourages students to use computers especially in the following two ways. Firstly, students use computers when working on their assignments, during academic research on the Internet, and when communicating electronically with the lecturers and their fellow students. Secondly, the IT courses offered to AAU students teach them to use everything that information technologies offer and lead them to acquire specific skills. The University also uses Skype videoconferencing and several long-distance lectures were able to take place thanks to interconnected PCs, projectors, webcams, and the sound system and microphone in the lecture hall.

Recently, AAU has installed a VoIP infrastructure, placing VoIP telephones in all lecture halls. The reception can now be easily contacted, as can specialized IT help.

11. Internationalization

AAU's Strategy in the Field of International Cooperation (2014 Priority Areas)

- 1) In 2014, AAU continued developing its cooperation with Chapman University, CA, USA;
- 2) In 2014, the University also successfully finalized the process of updating ongoing contracts that have been entered into under the Erasmus LLP program. All of these contracts now fulfil the requirements and criteria of the program's successor Erasmus+;
- 3) AAU also continued cooperating with the following institutions, with which it organizes student exchanges: University of Hawaii, Hilo, USA; Florida Atlantic University, USA; Hankuk University of Foreign Studies, Korea. The University also initiated student exchanges with Kookmin University, Korea;
- 4) AAU continued cooperation on the basis of student exchanges that had been entered into under the Erasmus LLP program;
- 5) AAU joined the Higher Education Mobility consortium coordinated by the European Development Agency (ERA), which provides funding for student internships in the European Union. The project's first mobilities were planned for the spring of 2015;
- 6) For the second year in a row, AAU has organized the International Consulting Practicum together with Virginia Commonwealth University. AAU also organized a summer school, co-hosting the event with the Department of Slavic Languages and Literatures of Harvard University;
- 7) During the EAIE conference (a meeting of internationalization specialists), which was held in Prague in September 2014, AAU organized a campus tour. EAIE is the largest conference of its kind in Europe and the second largest conference of its kind in the world (after NAFSA); AAU was one of the six universities and the only private university selected for a campus tour during EAIE 2014. The conference was attended by 46 specialists on higher education from 19 countries and 4 continents;
- 8) AAU continued networking with expat societies throughout the world and in September 2014, co-hosted the 8th International Compatriotic Festival, held in Prague. AAU also approached the Slavic Studies departments of universities throughout the world (especially in the USA and the UK), resulting in an active cooperation especially with East Carolina University in the USA;
- 9) In 2014, AAU strengthened the trend of semester and year-long studies of study abroad students, especially from the USA. AAU again welcomed guest professors from the Prague diplomatic community and the Ministry of Foreign Affairs of the Czech Republic.

12. Quality Assurance and Completed Activities Evaluation

Education Quality Evaluation System (Internal and External Evaluation)

The Learning Outcomes and Assessment Committee, which focuses on the analysis and measurement of learning outcomes, worked intensively throughout 2014.

In 2014, the Accreditation Commission of the Czech Republic extended the accreditation of the following study fields: *Business Administration; Humanities, Society and Culture; International Relations; International Relations and Diplomacy.* One new study field was accredited in 2014 – *Visual Arts Studies*.

Student Participation in the Internal Evaluation System

AAU uses a standardized evaluation questionnaire based on ones used at US universities. The students are asked to fill the questionnaire in during the last lecture before the final examination, and the lecturer has to leave the room while the questionnaires are being filled out. After everyone has finished, one of the students hands the filled-in questionnaires to the lecturer in a sealed envelope.

The questionnaire is anonymous and focuses on the lecturer's teaching style, their approach to their students and the contents of the course. Each question can be answered on a response scale.

The questionnaires are then evaluated by the respective Deans. The results of the students' evaluations are compared with results from previous semesters and with the results of other lecturers. Should any issue arise, it is discussed with the lecturer in question. Serious teaching deficiencies, visible in the students' evaluation over a number of semesters and verified by other sources, can lead to the lecturer's dismissal (this has occurred several times already). However, although the questionnaires are an important tool for the evaluation of the lecturer's teaching methods, interpreting them requires objectivity and experience and they are not the sole method on which the lecturer's evaluation is based. All AAU lecturers are always notified of the evaluation results.

AAU students also sit on advisory boards that focus on the quality of teaching.

In 2014, AAU once again asked its students to evaluate the University through the *Satisfaction Survey*, in which they evaluate the services – both academic and non-academic – offered by AAU.

The Student Council was also active in 2014. Any suggestion it makes regarding the quality of teaching is taken very seriously.

Student Complaints and Suggestions

AAU's leadership responds to all student complains and suggestions, and does so immediately. Complaints and suggestions are usually initiated through individual or group Petitions – for further details, please see the *Student Handbook* (www.aauni.edu).

13. Conclusion

In 2014, Anglo-American University continued to fulfil its long-term strategy for 2011–2015 and started working on its strategy for 2015–2020.

In the past year, the University celebrated several major achievements. The most important of these are as follows:

- 1) WASC Accreditation is one of AAU's priorities. This is a long-term project the decision-making committees of AAU decided to aim for the WASC Accreditation during the academic year 2010/2011.
 - In September 2014, AAU was evaluated on-campus by a WASC team of experts. The evaluation focused mainly on the effectiveness of the teaching process and on management changes.
 - In 2015, AAU aims to fully focus on the evaluators' recommendations;
- 2) The accreditation of most study fields and programs at AAU ends in July 2015; therefore the University has continued processing applications for accreditation extension. In 2014, the accreditations of the following study fields were extended: Business Administration; Humanities, Society and Culture; International Relations; International Relations and Diplomacy. A new degree field of study, Visual Arts Studies, was newly accredited;
- 3) In 2014, several administrative changes took place at AAU, the most significant of which is Miroslav Svoboda, Ph.D., becoming the head of the School of Business Administration;
- 4) In 2014, there were significant member changes in the Board of Trustees and the Supervisory Board (see Chapter 2 for more details);
- 5) Over the past year, AAU organized several academic conferences and symposia. The University's academic staff attended a number of academic conferences both in the Czech Republic and abroad;
- 6) As in previous years, the AAU art gallery, Art Space, hosted a number of exhibitions and events in 2014. The AAU Library organized several interesting literary and musical evening events.

To conclude this brief overview, it can be said that for AAU, 2014 was a successful year, and that the negative impacts of the economic and demographic crisis were not felt.
